1. Acceptance of Terms

2. About PPWA

Pearls People Welfare Association (PPWA) is an Association registered under Registration No. **F-61698** on **26 July 2022**, with its registered office at Gat No. 1056, Maruti Mandir, Napte Vash, Shirur, Pune - 412208, Maharashtra, India.

3. Website Purpose

6. User Responsibilities
